PRINCEOFPROXIMITY lagged back, entered the lane four wide, rallied, drifted in bothering CAN'T BUY LOVE at the sixteenth pole and then bumped with ALABAMA'S JUMPIN just before the line while besting that one for the win. ALABAMA'S JUMPIN tracked the leader along the three path, gained inside, drifted out some bothering CAN'T BUY LOVE and then battled the winner while being bumped by that one nearing the wire. CAN'T BUY LOVE was unhurried, gained five wide on the turn, rallied, lodged a bid from between foes nearing the sixteenth pole, was shut off by both of them and was forced to take up sharply. HAUNTER set the pace, was hooked and weakened. HERECOMESDAJUDGE was unhurried along three path and then lacked a rally. BEHRACUDA lagged back off the rail, was outrun. DISTRICT CHIEF was well placed along the four path and tired. GIN GOES FOR IT was well placed saving ground and tired. JADES KNIGHT forced the issue early, tracked along the four path and tired. A stewards inquiry was posted concerning the stretch run, resulted in the disqualification of the winner from first and was placed second for interference with ALABAMA'S JUMPIN just before the line.
